## **PROFESSIONAL SERVICES**

**BASIC SERVICES OF FUNERAL DIRECTOR & STAFF.....\$420.00**

Our basic services charge includes but is not limited to 24-hour availability of funeral director and/or staff to respond to initial request for services, arrangement conference with family or responsible party, arrangement of service, tribute, or memorialization. Collecting vital statistics and biographical information for the Death Certificate. Completion of the Death Certificate through assisting parties such as hospitals, cemeteries, medical offices, and all parties involved in the registering of the Death Certificate. Refrigerated sheltering of the decedent. Also included in this charge are overhead expenses relative to our facilities such as professional licensing, administrative services, insurance, maintenance, building and utility expenses, taxes, legal and accounting fees, recording keeping, equipment and inventory expenses. This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select.

(This fee is already included in our charges for direct cremations, immediate burials, forwarding or receiving remains, and other packaged funeral offerings as allowed by law)

## **PREPARATION**

### **EMBALMING.....\$750.00**

Embalming is not required by law for certain cases or services. Embalming may be necessary, however, if the selected funeral arrangements call for such preparation. If you do not want embalming, you typically have the right to choose an arrangement that does not require you to utilize these services, such as direct burial or direct cremation.

### **Forwarding Embalmed Remains to Another Funeral Home.....\$1950.00**

This fee includes transfer of remains into our care, basic services of funeral director and staff, embalming, placement and dressing into casket or air tray/combo tray, coordination of flight, necessary authorizations, and local transportation to Sacramento International Airport.

(This fee does not include airline costs, casket, air tray/combo tray needed for flight, storage over 10 days, or a 2<sup>nd</sup> driver when necessary)

### **Forwarding Remains Without Embalming to Another Funeral Home.....\$1750.00**

This fee includes transfer of remains into our care, basic services of funeral director and staff, unembalmed sanitation and cleaning, dressing and placement into casket or air tray/combo tray, coordination of flight, necessary authorizations, and local transportation to Sacramento International Airport.

### **Receiving Remains from Another Funeral Home.....\$1400.00**

This fee includes temporary shelter of remains, basic services of funeral director and staff, transportation of remains from Sacramento International Airport, and delivery to cemetery or crematory.

(This fee does not include the use of staff visitation, rites and ceremonies, any other services including sanitation or preparation, embalming, storage over 10 days, casket, or merchandise not specifically listed)

In the case of a rush cremation or burial for religious purposes or at special request, our services are limited. Arrangements for expedited services must be coordinated prior to burial or cremation.

## **Return to Home as Life Giving Soil...**

In 2027, California Mortuaries will be able to offer Human Composting services, which will allow us to provide a unique, alternative method that won't contribute emissions into our atmosphere and will capture CO2 in our soil and trees. In order to provide these services before 2027, Simple Traditions has partnered up with Return Home in Auburn, WA. Feel free to speak with our staff about how Simple Traditions is pursuing a clean, green future for final arrangements.

### *The Process...*

"The body is placed in a vessel along with wood chips, alfalfa, and straw. Over a month, microbes work to break the body down into a cubic yard of soil, which can then be used in a loved one's garden, or anywhere else."

**Return Terramated Soil/Remains via USPS Priority Mail Express.....\$150 & up**

Terramated soil will be placed in a standard sized container prior to shipment. If more than the standard amount of soil is requested to be returned to the family, please contact our services for specialized pricing.

### **Bamboo Burns Cleaner...**

Independent lab testing showed that our Bamboo cremation containers burn at a lower temperature than traditional cardboard containers and emit a cleaner white smoke.

Bamboo cremation containers release H<sub>2</sub>O, O<sub>2</sub> and CO<sub>2</sub> when burned, and do not emit the high-weight polymers and carcinogens that cardboard containers do when burned.

### **Return to the Earth...**

Burial typically occurs in a hand-dug grave at a green cemetery, using a shroud or eco-friendly casket crafted from wicker or similar sustainable material, and does not include the use of a vault. The body is not embalmed and will return to the earth naturally over time, along with the shroud or casket. This alternative to traditional burial also encourages family participation and is often more healing and meaningful for mourners.

We do **not** allow additional time for simple identification viewings, and a **maximum of 7 people** will be permitted inside the viewing room. Additional fees will be applied if Minimal preparation and viewing container will be provided prior to viewing your loved one. This does not include a casket, embalming, dressing, or further preparation.

### **1 HOUR VIEWING SERVICE.....\$895.00**

This service is located at our chapel facility in Rocklin, CA. A maximum of 30 people will be permitted inside the viewing room. A minimal viewing container will be provided for your loved one. Embalming, dressing, preparation, and a casket are **not included**. (Please refer to pg. 2 for preparation services & fees)

### **WITNESS CREMATION SERVICE .....\$475.00**

This service lasts 1 hour and is located at our crematory in Rocklin, CA. This does not include preparation, viewing the decedent, or dressing unless requested at an additional charge. A maximum of 10 people will be permitted within the cremation chamber area.
