## **BASIC CREMATION PACKAGE.....\$1895.00**

This package includes the following:

### **BASIC SERVICES OF FUNERAL DIRECTOR & STAFF \$620.00**

This is a standard charge for each family we service. It applies to burial or cremation. It includes consulting with the family to make necessary arrangements, sheltering human remains, preparing and filing necessary documents, obtaining necessary authorizations and permits, and coordinating with the crematory or other third parties. In addition, this fee includes a proportionate share of our basic overhead costs.

### **TRANSPORTATION \$500.00**

Includes 1-2 people transporting the deceased from the place of death within 30 miles of Sacramento County to our facility. Additional mileage fees will be applied for removal from outside of these areas.

### **REFRIGERATION \$275.00**

A few days will elapse from death until cremation is completed, which makes refrigeration necessary.

### **CREMATORY FEE \$450.00**

**WITNESSING CREMATION..... \$600.00**

Family will be able to witness their loved one being placed into the cremation chamber. Ashes are made available the next business day.

**EMBALMING OF DECEASED..... \$900.00**

Embalming is not required but may be necessary for extended memorial services with an open casket. This does not cover the embalming of a decedent who is a donor or has undergone an autopsy.

**EMBALMING OF DONOR/POST DECEDENT..... \$995.00**

Embalming is not required but will be necessary to view a decedent who has been autopsied or has undergone a donation procedure.

**DRESSING OF DECEDENT..... \$600.00**

Embalming is not required for dressing an unembalmed decedent, but it may be necessary based on the decedent's condition. Dressing will not be an option for unembalmed donors or autopsied decedents.

### **CASH ADVANCES**

**CERTIFIED COPIES OF DEATH CERTIFICATES..... \$26.00 each**

We order and prepare the death certificate through the county of passing.

**DISPOSITION PERMIT..... Included**

**PACEMAKER REMOVAL..... \$75.00**

Removal of the pacemaker before cremation is required for both the safety of the decedent and the cremation chamber.

**SACRAMENTO CORONER'S..... \$400.00**

If decedent has been taken to the Sacramento County Coroner and is not a minor or homicide victim, a charge for investigative services and transportation may be enforced by the Sacramento Coroner.
